

The list is enclosed herewith as ANNEXURE R-2 (pg 5 to pg 6).
- 5. That the Committee vide its letter dated 5.9.2023 requested Income Tax Department to evaluate properties in Bibinagar Mandal, Yadadri District of Telangana A copy of covering letter dated 5.9.2023 is enclosed herewith as ANNEXURE R-3 (pg 7 to pg 7).

That during the course of hearing dated 24.1.2024 it was pointed out by some prospective bidders of Telangana properties that the properties in Telangana has not been completely evaluated. Therefore the Committee forthwith compared the list provided to and evaluated by Income Tax department and found that the properties provided vide letter dated 20.2.2023 were not completely evaluated.

7. That the Committee immediately, vide letter dated 30.1.2024, again supplied the list of properties in Chhotoupal Mandal, Yadadri District of Telangana which were not evaluated earlier by Income Tax Department with a request to evaluate the same. A copy of


