Most Respectfully Submits:

1. That the aforementioned case bearing Writ Petition (CIVIL) No. 188 Of 2004 is pending adjudication before this Hon'ble Court.
2. That it is most respectfully submitted that in the present case, this Hon'ble Court was pleased to constitute a committee to take into its custody all assets of Golden Forests (India) Ltd. ("GFIL") and its subsidiaries companies and thereafter called the all creditors of GFIL and its subsidiaries companies to submit their claims before the said committee.
3. That pursuant to the directions of this Hon'ble Court, the said committee itself and through the Income Tax Department, has made various attempts, to auction the properties of GFIL, GPL and its subsidiaries companies.
4. That the applicant is one of the Director of Sadashiv Castings Private Limited and an interested buyer and competent to file the present application in the above-mentioned pending matter before this Hon'ble Court. It is pertinent to mention here that the present

application for direction is being filed through its one of the director of M/s Sadashiv Castings Pvt. Ltd. (PAN Card), the Board Resolution dated 10.07.2024. True copy of PAN CARD of company is annexed here to as **ANNEXURE-A-1** (Page No. 14).

True typed Board Resolution is annexed hereto as **ANNEXURE-A-2** (Page No.15 to 16).

True copy of Aadhar Card of the applicant is annexed hereto as **ANNEXURE A-3**(Pg No.17 to 18).

True copy of Certificate of Incorporation is annexed as **ANNEXURE A-4.** (Pg No.19 to 20).

True copy of Balance Sheet of the company for the Assessment year 2023-2024 is annexed hereto as **ANNEXURE A-5.** (Pg No.21 to 22).

5. That the applicant has authorized Sh. Rohit Sabharwal S/O Sh. Bishamaber Singh R/O 42, Jaggi Colony, Ambala City, Ambala, Haryana-134003, to act in his name and on his behalf and to appear before the Hon'ble Supreme Court Of India (Civil Appellate Jurisdiction), IA NO. ....in Writ Petition (Civil) No.188 of titled as ' M/S Raiganj consumer Forum V/s Union of India and Ors.' In this regard..... has executed a special power of attorney in favour of Mr.Rohit Sabbharwal.

True copy of Special Power of Attorney dtd.14.08.2024 is annexed hereto as **ANNEXURE A-6** (Pg No.23 to 25).

6. That the applicant came to know that the all the properties situated in Punjab and the applicant is ready to purchase all the properties situated in Punjab.
  
7. That the applicant is ready and willing to purchase all the properties mentioned above of GOLDEN FOREST PVT. LTD., and its sister companies situated in Punjab with the permission of this Hon'ble Court. The applicant is head quartered in Capital of Punjab and Haryana i.e. Chandigarh strategically secures expansive land parcels and boasts significant capital derived from both domestic and Foreign Direct Investment (FDI). This financial strength propels the company into embarking on large scale project that prioritize environmental friendliness while simultaneously creating valuable local employment opportunities. The applicant company has global ambitions to extend beyond cultivation on a global scale. The applicant company has the financial wherewithal

to bid for the subject properties and to take part in the process.

8. That with the kind intervention of this Hon'ble Court the investors of Golden Forest and its Subsidiaries got an opportunity to agitate their grievances and seek justice against the Golden Forest and its subsidiaries. That on several occasions in the last 19 years, this Hon'ble Court passed directions to recover the amount so siphoned by Golden Forest and its subsidiaries through sale of their assets/ properties of Golden Forest, the Investors have only received a fraction of their respective claims, however, 70% of claims of the investors has been settled and disbursed.
9. That present application is being filed for impleadment and appropriate directions concerning the property of M/s Golden Forest India Ltd., (GFIL), its subsidiaries, sister concerns, trust, society etc., in the entire state of Punjab including all properties which have been declared as surplus lands by the state of Punjab, all land situated in Punjab State and seeking approval to the payment scheme of the applicant for purchasing /taking over all the assets of the Golden Forest India Ltd. And its subsidiaries, sisters concerns, trust, society including the properties which are in the names of Directors

etc. on “as is where is” basis for a lump sum amount off Rs.400 Crores (Rupees Four Hundred Crores) since 70% of the claims of the investors have been settled and 30% claims of the investors are pending which could easily be compensated out of the proposed amount including the incidental expenses including the surplus fees before the Hon’ble Court and further with the offer of making the sure complete payment at the time of registration of sale deed and delivery of possession at the time of registration of sale deeds with further request before the Hon’ble Court to issues directions to the state not to declare the private land under the control of the company (GFIL) to be a surplus land which can never be as per the law of the land.

10. That thereafter, the GFIL Committee uploaded the list of properties on its website. The properties were categorized into 4 Parts/Categories:

**Part A** consisted of properties which were denoted as “Ready for Sale”.

**Part B** consisted of properties under litigation.

**Part C** properties were declared as surplus lands by State of Punjab and State of Uttarakhand.

**Part D** consisted of properties which were yet to be verified and identified.



The subject property was listed under Part C. Properties/lands to be identified (As per Dr. Namavati Reprot).

11. That the applicant's offer is also to be considered in light of the following peculiar facts of the assets of Golden forest and its subsidiaries:-

- a. That may properties on sale and/or belongings to M/s Golden Forest India Pvt. Ltd. And its subsidiary companies do not have clear title documents in not perfect and thus the market value of such properties is substantially less in value or no value at all;
- b. That several properties of Golden Forest and its subsidiary companies may be under occupation of third party and thus would not even fetch the circle rate as it would involve cost in terms of money and time to get the actual physical possession of such properties.
- c. The applicants offer is based on the valuation of the assets of M/s Golden Forest India and its subsidiary companies on as is where is basis;

- d. That the applicant is ready to pay charges to remove surplus title on the properties of Golden Forest India Ltd., and its sisters companies, if any, then the applicant is ready pay charges to the Punjab Govt.
  - e. That all the properties of Golden Forest India Ltd. And its sisters companies buildings situated in Punjab are very old structure buildings and not for using purpose.
  - f. That in the properties of Golden Forest India Ltd., there are illegal mining around 10ft on the said properties due to which the value of the properties i.e. Village Peer Machala, Village Sanauli Tehsil Zirakpur SAS Nagar Punjab, Village Bijanpur, Village Samgoli, Teshil Derabassi SAS Nagar punjab, getting down.
  - g. That the Hon'ble Court consider the proposal of the applicant, then the applicant shall immediately pay 30% rest amount to the investors.
12. That the applicant seeking permission before this Hon'ble Supreme Court that the applicant company seeking approval to the payment scheme of the applicant for purchasing /taking over all

the assets of Golden Forest India Ltd., and its subsidiary companies lands situated in Punjab on as is where is basis for a lump sum amount of Rs.400 Crores (Rupees Four Cores) or on amount higher proposal in Punjab state.

13. That the applicant ready to submit 20% amount of the above said properties proposal for the satisfaction or as per the direction of this Hon'ble Supreme Court.
14. That at the intervention of present applicant is necessary and proper to the present proceedings for the following among other, reasons:-
  - A. BECAUSE the above-mentioned similar petition/ applications are already pending before this Hon'ble Court seeking grant of similar relief, hence, fresh petition is not being filed for the sake of brevity and convenience of this Hon'ble Court.
  - B. Because the applicant is financially sound and can purchase the above-mentioned property at an amount of Rs 400 crores.
15. That the applicant is a Performa buyer of the above- mentioned property and he is interested to purchase the above-mentioned properties as per

the offer of applicant and/or with the permission of this Hon'ble Court.

16. That the presence of the applicant is necessary in order to participate in the auction (if any) of above-mentioned properties, conducted.
17. That by adding the applicant as buyer of above-mentioned property, no prejudice will be caused the parties already on record; neither will fair trial of the questions in controversy be prejudiced. On the other hand, not allowing the applicant to intervene in the present proceedings will cause serious loss to the applicant.
18. That this application is bona fide and in the interest of justice.

**PRAYER**

It is therefore, most respectfully, prayed that this Hon'ble Court may be graciously be pleased to allow this application and be pleased to-

- a) To permit the applicant to be intervene the aforesaid matter and to participate as a buyer.

- b) Allow the applicant wants to purchase the above-mentioned property in a good price.
- c) Pass any order or further order(s) as your Lordships may deems fit and proper in the facts and circumstances of the case and in the interest of justice.

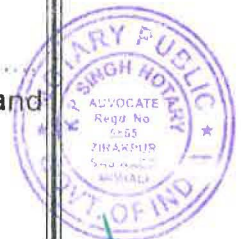


