- 1. That the proceedings referred to above are pending before this Hon'ble Apex Court consideration.
- 2. That it is most respectfully submitted that in the present case, this Hon'ble Court was pleased to constitute a committee to take into its custody all assets of Golden Forests (India) Ltd. CIT-1, INDORE published a valuation report of all valuation report of all the properties i.e. Rs.1,85,81,08,372/- page no. 176-230.






