APPLICATION FOR IMPEADMENT

The humble application on behalf of the
Applicant above named: -

MOST RESPECTFULLY SHOWETH:

1. That the above noted Writ Petition (Civil) No. 188 of 2004 is pending before this Hon'ble Court for adjudication.
2. That this Hon'ble Court was further pleased to direct that the properties and assets of Golden Forests (India) Ltd. ("GFIL") and its subsidiary companies be disposed, in accordance with the procedure and terms as approved by this Hon'ble Court, so as to secure the maximum possible realization from the sale of such properties.
3. That the Applicant is a law abiding permanent citizen of India. The Applicant has approached this Hon'ble Court bona fide, seeking appropriate reliefs in accordance with law and in the interest of justice.
4. That M/s KANYA PROPERTY PRIVATE LIMITED having registered office at Chandigarh Extension, NJ-22, (Chandigarh-Delhi Highway), Near – Ambala, Tehsil- Rajpura, District- Patiala, Punjab, is a subsidiary company of M/s GOLDEN FOREST (INDIA) LTD.
5. That M/s KANYA PROPERTY PRIVATE LIMITED vide Board of Directors meeting dated 05.12.2000 passed a Board Resolution for disposal of **Land Unit measuring total area 0.659 Hector bearing Khasra No. 870Min (0.308), 875 Min (0.037), 893 Min (0.314) total area 0.659 Hector situated at Village –East Hope Town, District- Dehradun** which was the property of the said company. Through this resolution, it was

resolved that the said land unit is hereby disposed off. But it is submitted that the said property has not been sold to any one. In addition to that, M/s KANYA PROPERTY PRIVATE LIMITED duly convened a meeting of its Board of Directors on 05.12.2000 at 11:30 A.M., wherein a Board Resolution was validly passed authorizing the execution of the transactions and acts contemplated therein, including the execution of documents relating to the aforesaid property through its authorized representative. The said resolution was passed in accordance with the provisions of the Companies Act, 1956, as applicable at the relevant time, and has remained valid and binding upon the Company.

6. That it is respectfully submitted that the Applicant possesses the requisite financial capacity, resources, and wherewithal to purchase the said property for valuable consideration at a fair and competitive market value.
7. That it is submitted that presently the entire Khasra No. 870 Min , 875 Min, 893 Min, Village East of Town Tehsil Vikasnagar District Dehradun including the land covered under the Board of Resolution, continues to stand recorded in the revenue records in the name of the State Government. Furthermore, the Khasra No. 870 Min, 875 Min and 893 Min, is a big chunk of land which includes the land which the Applicant proposes to purchase before this Hon'ble Court. The said land is agriculture land.
8. That the Applicant is a prospective purchaser and is fully competent to file the present Application in the above-captioned

pending matter before this Hon'ble Court. The Applicant is filing the present Application in his individual capacity, being genuinely interested in purchasing the above mentioned property subject to the approval, directions and terms and conditions of this Hon'ble Court impose.

9. That the Applicant is ready and willing to comply with such terms and conditions, including deposit of the consideration amount or any other conditions, as may be imposed by this Hon'ble Court.
10. That it is further submitted that the Applicant undertakes to abide by all such terms and conditions as may be imposed by this Hon'ble Court with regard to the purchase of the said property, including payment of the entire sale consideration in the manner and within the time stipulated by this Hon'ble Court. The Applicant is financially sound and possesses the requisite financial capability to complete the proposed purchase without any impediment, thereby ensuring fair value realization and facilitating the expeditious disposal of the property in accordance with the directions of this Hon'ble Court.
11. That the Applicant is bona fide ready and willing to purchase the above mentioned property at such valuation, reserve price, or consideration as may be determined, approved, or accepted by this Hon'ble Court, subject to the permission, approval, and directions of this Hon'ble Court.
12. That the Applicant has not filed any similar or other petition/application for the same cause/issue before this Hon'ble Court earlier.

In view of the submissions made herein above applicant most respectfully prays that this Hon'ble Court may kindly be pleased to:-
